# Glendale Updates Preservation Ordinance

Glendale Now Aligned with Other Preservation-Minded Communities

n October, at the recommendation of the city's Historic Preservation Commission (HPC), the Glendale City Council approved several updates to the city's preservation ordinance. The revisions make the ordinance consistent with standard preservation practices of the California State Office of Historic Preservation.

One of the most noteworthy changes to the ordinance is the provision that allows the City Council – by a supermajority vote – to list a property on the Glendale Register of Historic Resources without the owner's consent. While it is likely that this option will rarely be invoked, it does provide a useful tool in preventing unwanted demolition or major alteration of a uniquely important or architecturally significant structure. Many neighboring cities, including Los Angeles and Pasadena, do not require the owner's permission to landmark a building, so this change aligns Glendale with surrounding communities.

Some of the other major changes to the preservation ordinance include: clarifying the definitions of "major alterations" and "minor alterations," as well as adding new language for "demolition by neglect" and "visible from the public right-of-way"; simplifying the thresholds for potential staff-levels approvals and mandatory HPC review; revising the historic designation criteria to be consistent with the California and National Registers; and adding a designation criterion that allows some flexibility for listing structures that exemplify the city's early heritage.

TGHS strongly supported these much-needed changes to the city's preservation ordinance.

# Montrose Celebrates Its 100th Anniversary

ontrose will officially celebrate its 100th birthday this month. Part of the original 36,000 acre land grant given to Jose Maria Verdugo in 1784, Montrose was promoted by developers who took advantage of the healthy climate in a beautiful setting that could be accessed conveniently by the Glendale and Montrose Railway.

The Montrose Centennial Celebration will take place February 22-24. The fun, food and music will include pony rides, square dancing, a petting zoo and more. On February 23, the Montrose-Crescenta Branch Library hosts a StoryWalk at 10:30 am, a Special Collections talk by Mike Morgan at 1:30 pm and a History Drive from 3:00-5:00 pm, during which documents and photos brought in by the public will be scanned.

In conjunction with the anniversary, on February 20 Art Cobery will speak at the Glendale Central Library about the devastating and deadly 1934 Crescenta Valley flood, which is the subject of his new book, *The Great Crescenta Valley Flood - New Year's Day 1934*. The presentation commences at 7:00 pm. And last month, author Robert Newcombe gave a slide presentation on his new book *Montrose: Images of America*.

TGHS is pleased to co-sponsor events recognizing this important milestone, which are being organized by the Historical Society of the Crescenta Valley.

# PRESIDENT'S MESSAGE



appy New Year! Like many of you, The Glendale Historical Society (TGHS) has taken the opportunity that a fresh, new calendar provides by laying out our plans for the next 12 months. In doing so, the Board of Directors came up with a number of ambitious but realistic goals to help guide our activities in the year ahead:

# INCREASE OUR MEMBERSHIP TO 500 BY THE END OF THE YEAR

More and more people are joining Glendale's preservation movement, and membership in TGHS now exceeds 400. However, given the size of Glendale's population, I know we can do better. As a non-profit organization, annual membership dues are one of our most important funding sources. But even more than that, growing and retaining our membership is an essential part of our efforts to remain a strong and effective advocate for historic preservation. Quite simply, the more members we have, the stronger our voice will be. You can help us achieve our goal of 500 members by reaching out to other like-minded individuals and encouraging them to support preservation by joining TGHS.

# INCREASE THE DIVERSITY OF OUR MEMBERSHIP TO BETTER REFLECT OUR POPULATION

Membership in TGHS is open to anyone and everyone who values the importance of celebrating and conserving our city's rich history and architectural heritage. After all, our primary purpose is to bring people together to preserve, enhance and enjoy the local landmarks and historic homes and neighborhoods that help define and distinguish our community. Throughout our efforts – from education to outreach to advocacy – TGHS views inclusion and diversity in all its forms as essential to the goals of historic preservation. You can help us expand our membership by talking to your friends, family, neighbors and local businesses about preservation and inviting them to take part in TGHS events and activities.

# Support the establishment of more historic districts by awarding at least two historic district grants in 2013

TGHS is strongly committed to expanding the number of historic districts throughout the city. Last year, we established a new grant program to help defray the city's application fee of \$2,000 for neighborhoods that are interested in pursuing historic district designation. If your neighborhood is thinking about or working on a historic district application, please let us know. In addition to financial support, TGHS is willing to lend a hand in any way we can.

## REACH A MILESTONE OF 100 HISTORIC

#### LANDMARKS THIS YEAR

There are currently 96 properties listed on the Glendale Register of Historic Resources, just four shy of achieving an important milestone. TGHS will continue to reach out and encourage owners of potentially eligible homes and buildings to apply for historic designation. If you know of a property that might qualify for listing on the Glendale Register, you can help us achieve our target by persuading the

owners to pursue historic designation. Not only does listing a property on the Register help ensure that the home or building will be preserved for future generations, but owners of listed properties can receive a significant reduction in taxes in return for maintaining their historic properties.

# PREPARE AN INVENTORY OF GLENDALE'S HISTORIC RESOURCES

There are many architecturally significant properties in Glendale that are worthy of preservation and protection, and many of them are eligible for listing on the Glendale Register, as well as the California and National Registers. However, more research needs to be done to identify, assess and document these potential historic resources. For years, TGHS has called for a comprehensive, citywide historic resources survey to help better preserve the historic charm and character of our neighborhoods and promote the adaptive reuse of our built environment. Starting this year, TGHS will begin the process of creating an inventory of historic properties in Glendale. More details to follow in the coming months, but if you are interested in being involved in this project, please let us know. We're going to need all the help we can get.

#### ADD A MAJOR FUNDRAISING EVENT

There are many costs associated with running a non-profit organization. While increased revenue from membership dues and home tour ticket sales has allowed us to sponsor more programs and events, improve our outreach efforts and provide some financial support to neighborhoods pursuing the historic district application process, more funds would allow us to be an even stronger advocate for preservation. To that end, the Board has decided to add another major fundraising event to our schedule. Stay tuned for more information!

I look forward to working with many of you over the course of the year to achieve these goals. And if you are not already actively involved in TGHS, please consider pitching in. As an all-volunteer organization, we can always use more assistance with event planning, membership and outreach, fundraising, communications, preservation advocacy and the Doctors House Museum. Not only will you help to advance the mission of TGHS, but you will have valuable experiences and make new friends.

# Future of Post Office Remains Uncertain

hile there has been no public announcement issued or community meeting scheduled, TGHS remains concerned about the fate of Glendale's historic main post office, located at 313 East Broadway.

U.S. Representative Adam Schiff recently sent a letter urging the U.S. Postmaster General to keep the Broadway post office open, arguing that closing the office "would mean a significant degradation in services for the community."

While TGHS remains opposed to the sale or closure of the post office, the good news is that the building is listed on both the Glendale and National Registers. Under Federal law, an enforceable preservation restriction must be placed on the building if it is sold.

Built in 1934, the impressive Italian Renaissance-style building was designed by George M. Lindsay and features a beautifully decorated public lobby that includes marble walls and floor, ornamental bronze grille and panel work and a ceiling of painted panels with relief

TGHS will continue to work closely with city officials and will keep our members apprised as more information becomes available.

# Report Unpermitted Window Replacement

he city of Glendale requires permits for window replacements. Too often, property owners are unaware of the need to obtain a permit or choose to replace their windows without a permit.

It is important that all window replacements, particularly on older structures, go through the permit process in order to ensure that replacement windows are consistent with the character of the structure and the neighborhood. (It is worth noting that original, old-growth wood or steel windows, if properly cared for and maintained, rarely need to be replaced.)

To verify permit status or place an anonymous complaint regarding projects that you observe, call the city of Glendale's Neighborhood Services Department at 818-548-3700. Be prepared to give a correct street address of the property in question, as well as a description and location of the problem on the property. Also make sure to get the name of the customer service representative and assigned case number for future follow-up.

# Kolonialvue Is Newest Addition to Glendale Register

he 96th addition to the Glendale Register of Historic Resources is "Kolonialvue," a home in the Verdugo Viejo neighborhood.

This two-story, Colonial Revival-style home was built in 1932. The home resembles Mount Vernon, with a symmetrical façade and a full-width front porch underneath a roof supported by six Doric columns. The main roof has three gabled dormers, each with a small divided light window.

Some of the most unusual features of the home are in the back yard: a bridge, railing, and a lamppost made of concrete sculpted to resemble wood. This rare *faux bois* technique is usually found in Mexico and the American Southwest; only one other location in Glendale (Rockhaven Sanitarium) is known to have it.

# Volunteer at the **Doctors House Museum**

very Sunday and on many weekdays, members of a team of 20 faithful volunteers and TGHS Board Members have lopened the doors of the Doctors House Museum to the public, continuing a three-decade tradition. Throughout the past year, a total of 1,010 volunteer hours were expended guiding visitors through the house on tours and during special events and exhibits and conducting behind-the-scenes administrative work.

In 2012, 2,100 people, 846 of whom were school children, visited the museum. The school children all got hands-on experience with the games and chores of a century ago. The school tours were led by volunteers Judy Cabrera, Isabelle Meyer and Peter Rusch.

Some of the special exhibits and events included a Victorian Easter Egg Hunt, an election display, Art in the Park, Beneath the Veil (an exhibit on Victorian mourning practices) and dinner for the winners of the yearly raffle. The annual Candlelight Tours during the December holidays were also well attended.

The Queen Anne Victorian house has always attracted people to its front door, from the time patients sought medical care from the doctors who lived there, to the visitors who rediscover the past when they experience it today. And, most importantly,



the Doctors House serves as a proud symbol of community activism and historic preservation. It was, after all, the threatened demolition of this house that sparked the formation of The Glendale Historical Society and the city's preservation movement.

That spirit of volunteerism is needed now more than ever to keep the house in good repair and properly staffed.
