### NIODRARA DRIVE BECOMES CITY'S SEVENTH HISTORIC DISTRICT

n April 26 the Glendale City Council unanimously approved creation of the Niodrara Drive Historic District. An impressive 75% of property owners signed the final petition to request designation.

Located immediately north of Verdugo Park, the historic district includes 32 houses and encompasses all of Niodrara Drive and Fernbrook Place as well as sections of Hillside Drive and Wabasso Way. Architectural styles are typically eclectic. The district includes an American Foursquare from 1912 - one of the oldest houses in the Verdugo Woodlands, Rudolph Schindler's 1942 Rodriguez House and a 1950 rustic Ranch by Robert Byrd, who designed the estate of movie star Robert Taylor among other notable projects.

Each historic district is unique. What sets this one apart is the ornamental river rock landscaping elements, including several ponds and stone, concrete and faux bois (an artistic imitation of wood) bridges designed to showcase the natural stream that used to flow through it.

The historic resources survey found that Niodrara Drive is also eligible for listing in the California Register of Historic Resources as one of the earliest subdivisions in southern California to reflect larger national trends of picturesque garden suburb design.

To celebrate Glendale's seventh historic district TGHS will offer another Niodrara Drive neighborhood walk soon so that members can learn more about this community treasure.

### Mills Act Extended to Historic District Contributors

n a big win for preservation, City Council unanimously approved a proposal, initiated by TGHS, to allow owners of historic district contributors in need of restoration to apply for Mills Act contracts starting in 2017. The Mills Act gives owners of historic properties a significant, permanent property tax reduction to offset the cost of preserving them.

Originally staff had sought to limit the number of contracts to six per year, with at least two reserved for historic district contributors and no more than four for properties listed on the Glendale Register of Historic Resources. TGHS is grateful to those of you who wrote to support expansion of the Mills Act program and to request that the hard cap on Glendale Register properties be lifted. The City agreed to process more than four such applications if time allows.

But the sad truth is that Glendale has significantly reduced its staffing levels in historic preservation in recent years, even as the number of historic resources continues to increase.

Eventually TGHS would like to see a more generous program like the City of Pasadena's, which offers up to 20 Mills Act contracts per year.

Contributors with an assessed value of \$1.5 million or less will be eligible for the contract. Owners need to submit a detailed plan for restoration, which may include structural upgrades, to qualify.

TGHS hopes that the new program will not only improve the condition of historic resources in Glendale neighborhoods by facilitating needed repairs, but that it will create another incentive for residents to come together to protect neighborhood history, aesthetics and property values by forming historic districts.



# Come Fly With Us to Grand Central Air Terminal Tickets on Sale for Annual Gala & Benefit

ou are invited to TGHS's third annual Gala & Benefit, Come Fly With Us, on June 11, 2016, 7:00 – 10:00 pm, at the beautifully restored and historic Grand Central Air Terminal.

Sponsored by **The Walt Disney Company** and **G&C Properties**, the festive evening will feature live music and a silent auction. Proceeds benefit TGHS's endowment and preservation funds.

Dedicated in 1929, Grand Central Air Terminal was designed by noted architect Henry Gogerty in an eclectic architectural style that combines features of Spanish Colonial Revival with Zigzag Moderne. The terminal played a pivotal role in the development of aviation in the United States and became the premier location for air travel in Southern California, frequented by Hollywood stars as well as notable aviation pioneers "Lucky Lindy," Amelia Earhart and Howard Hughes. Several movies were filmed at the air terminal, including *Bright Eyes* (1934) starring Shirley Temple.



At the Gala & Benefit, TGHS will present its annual awards in recognition of outstanding achievement in historic preservation. The recipients of this year's Preservation Awards are Grand Central Air Terminal and the newly established Niodrara Drive Historic District.

GHS is pleased to welcome Francesca Smith as its newest member to the Board of Directors. Francesca has been a member of TGHS's Preservation Advocacy Committee since 2012 and played an instrumental role in the creation of the Brockmont Park Historic District.

Francesca has been professionally involved in historic preservation for the past three decades and has served on other preservation and history advocacy non-profit boards. She completed the requirements for the Master of Science in Historic Preservation at Columbia University and holds a degree in a closely related field. Her professional and academic experience qualifies her as both an Architectural Historian and a Historian under the Secretary of the Interior's Professional Qualification Standards. in the National Environmental Policy Act, Section 106 and the California Environmental Quality Act (CEQA). Those experiences have ranged from nationwide and regional transportation and transit projects to certified rehabilitations.

Francesca was appointed to the Board earlier this year to fill a vacancy and will stand for election to a full two-year term in July 2016.

With her husband, Lee, she lives in a superb 1955 Ranch home in the Brockmont Park Historic District with two fantastic rescue dogs.

### PRESERVATION UPDATES

### Demolition of Craftsman Bungalows Postponed





upporters of preservation scored two more victories in April. First, after TGHS and its members raised objections, the City Council postponed a decision to approve a five-story, 44-unit multi-family residential building that entails the demolition of two historic Craftsman bungalows from 1912 and 1920 at 126, 128 and 132 South Kenwood Street.

A historic resources assessment prepared by a consultant chosen by the developer found the subject property ineligible for the Glendale Register of Historic Resources. However, TGHS provided evidence that the high-integrity bungalows exceed the requirements for local designation. Not only do they "embod[y] the distinctive and exemplary characteristics of [their] architectural style," but one was the long-time home of Reverend Clifford Cole, a prominent citizen who "significantly contributed" to the history of Glendale as a churchman, city official and journalist.

TGHS pointed out that review under the California Environmental Quality Act (CEQA) is triggered when there is disagreement between experts about whether a property qualifies as a historic resource. We believe the developer should be required to prepare an Environmental Impact

Report (EIR)—with the consultant selected by the City—which would have to consider alternatives to demolition.

Two weeks later the City's Design Review Board delayed consideration of another project, a three-story, 17-unit multifamily residential building at 401-409 Hawthorne Street, after a last-minute intervention by TGHS. The project involves the demolition of a Hip-Roofed Cottage from 1910 as well as a pair of high-integrity Clip-Roofed Craftsman bungalows built in 1922. In this case the City did not request preparation of a historic resources assessment but simply declared the properties ineligible for designation.

To deal with the ongoing problem of flawed or missing historic resources assessments, TGHS has requested that the City require intensive evaluations by qualified professionals without ties to project applicants for any demolition of buildings completed more than 45 years ago. This is standard best practice. TGHS has also asked the City to update and expand its 2007 survey of Craftsman houses, which did not include properties in commercial zones.

Neither the South Kenwood Street or Hawthorne Street project is going away. Whether we can ultimately save any of these bungalows from the wrecking ball depends on you. The City Council needs to know that Glendale residents want alternatives to the destruction of downtown Glendale's historic fabric as well as an appropriate and consistent review process.

### Rockhaven Receives State Historic Designation

n April 18 Rockhaven Sanitarium was approved for listing in the California Register of Historic Places by the California State Historical Resources Commission. Rockhaven was nominated by the nonprofit group Friends of Rockhaven; TGHS sent a letter to the state expressing its enthusiastic and unqualified support of the nomination.

The nomination will now be forwarded from the State of California to the Keeper of the National Register for review. Once the Keeper approves, Rockhaven will be formally listed in the National Register of Historic Places.

Rockhaven was founded in 1923 by psychiatric nurse Agnes Richards as a place where women suffering "mild mental and nervous disorders" could be treated. Located at 2713 Honolulu Avenue, Rockhaven is a unique cluster of historic buildings and landscaping of remarkable integrity. It is a rare extant and intact example of the residential healthcare facilities that were once plentiful in the region, and it continues to express the feeling and aesthetic of its original and quite specific purpose as a women's mental health facility, one of the first of its type in the nation. In addition, because of its reputation for excellent care, the facility included significant personages among its many patients, including Gladys Baker Ely, mother of Marilyn Monroe, and actress Billie Burke, who is best remembered as Glinda the Good Witch in *The Wizard of Oz* (1939).

TGHS supports the recent decision by the Glendale City Council to solicit proposals from potential development partners, particularly those with experience in restoring and adaptively reusing historic properties, to find a suitable project for the site. The buildings at Rockhaven have continued to deteriorate since the City purchased the 3.3 acreproperty in 2008 and further delays will only threaten their long-term viability. However, TGHS is disappointed that the City submitted a letter to the state opposing Rockhaven's nomination to the National Register and that it doesn't seem to understand that preservation of historic resources needs to be an integral part of the adaptive reuse process. TGHS is grateful to the Friends of Rockhaven for ensuring that the historic property now has the additional protections that it deserves and is committed to working with the City to ensure that any plans for the property: 1) identify, retain, and preserve Rockhaven's historic structures, features, and landscaping in accordance with the Secretary of the Interior's Standards for Rehabilitation; 2) result in the placement of Rockhaven on the Glendale Register of Historic Resources; and 3) honor the City's intention when it purchased Rockhaven by maintaining some right of public access, so that the community can, at long last, enjoy this special place.

Responses to the City's Request for Proposals (RFP) are due by June 14, 2016.
