

INTRODUCTION TO THE NEW GLENDALE HISTORICAL SOCIETY

Exciting things are happening in Glendale! Just a few short months ago a small group of concerned citizens banded together in an effort to save the Doctors' House, a venerable Victorian structure currently located on the corner of Wilson and Belmont. Out of the tremendous interest generated by that committee, as well as a growing awareness of the need to preserve our historical heritage, evolved the newly-formed Glendale Historical Society.

The bright plans for the future of the Doctors' House in our community became a reality when on December 26th the City Council generously agreed to donate an area of Brand Park for its new location where it will be restored and furnished to become a residential museum for the community's use.

The venture's estimated cost is \$200,000. But a grassroots campaign is already well under way to assume this cost. Individuals, small businessmen, several developers, and many community organizations have come forward, offering donations of labor, materials, funds, expertise, and volunteer hours. We're hoping that the House can be restored through a total community effort, making the Doctors' House truly "our house". National Register status and matching federal grants are also being applied for.

We are further working toward encouraging the developers of the 100 block of N. Brand Blvd. to preserve and restore the Egyptian Village Cafe by incorporating it in their plans for that block. The Egyptian Village Cafe is located in the vacant second floor above 131 and 133 N. Brand. A list of tax incentives and economic advantages to the developer is being compiled and National Register status is being applied for.

In order to help our community become aware of our architectural and historical resources we have planned:

- --slide presentations to service organizations and to school-age youngsters at the elementary, junior high, and high school levels;
 - --architectural and historical surveys of neighborhoods;
 - --walking tours;
- --the participation of individuals in our monthly meetings who are a part of, have contributed to, or are an authority on Glendale's historical or architectural past;

--making known preservation incentives to local homeowners and businesses in the form of economic benefits such as tax incentives and grants;

--development of a revolving fund to provide low-interest loans to owners of outstanding historical or architectural structures; and

--recognition of businesses and individuals who aid preservation.

If you are not already a member, we invite you to come join the fun! If you are a roofer, electrician, plumber, painter, etc., become an active participant in "your house", the Doctors' House. Anyone interested can become a member and work on a fund-raising or historical research committee. If time limits you, then send a contribution. Even \$1.00 will help make the Doctors' House Glendale's Success Story and the Glendale Historical Society a viable community organization working to preserve the past for our generation and those to follow. GOALS OF THE GLENDALE HISTORICAL SOCIETY

The Glendale Historical Society was formed to preserve our city's rich history by achieving these major goals:

- To promote community awareness and involvement through education.
 - To secure public recognition, and support for, the goals of this organization.
 - To sponsor tours, lectures, publications, and other cultural preb. servation programs.
 - To distribute newsletters to disseminate information, educate the public, and promote respect for Glendale and its irreplaceable cultural resources.
 - To encourage public examination of both public and private actions affecting Glendale's unique character.
- To develop programs of technical assistance which can lend their expertise to preservation minded individuals and groups.
 - To act as a storehouse of preservation information which can be obtained by citizens for private and public preservation.
 - To provide guidance and aid to groups wishing to imporve their b. homes, streets, and neighborhoods.

- 3) To direct the action of the Glendale Historical Society members to preserve endangered properties and protect materials of historic value for future generations.
 - a. To study and demonstrate effective alternatives to the continuing loss of Glendale's non-renewable cultural resources.
 - b. To develop a positive program of acquisition of private property for conservation, restoration, and resale, to administrate a revolving fund for this purpose, and to pursue a policy of acquisition and holding of architectural easements to maintain the integrity of significant cultural properties.
 - c. To encourage residents and businesses to find alternatives to destruction of existing structures.
