

Our major goal during the past year has been the completion of the exterior restoration of The Doctors' House. With the aid of an \$80,000 Community Development Block Grant and thousands of volunteer hours under the able direction of Marie and Glenn Luft, Jim Kieser, and Graham Latta, we succeeded. With Vonnie Rossman as chairman of the event, The Doctors' House and its newly landscaped grounds supervised by Bill Peacock were dedicated on September 19, 1982--a few days past the second anniversary of its move to Brand Park. Continued enthusiasm of volunteers and contributors and an additional CDB grant of \$96,000 will ensure restoration of the interior.

The size of The Glendale Historical Society continues to increase, with Membership Chairman Dorothy Krieger reporting about 40 new members during the year and a current total of 267.

Through our membership dues, our Benefactors' Campaign with Tye Veden as chairman, Audrey Hale's garage sales, and Joni Atkinson's and Margaret Hammond's tours, we raised \$15,000 this year. This allowed treasurer Dick Montgomery to make a first payment of \$6,000 to Gregg/ Gangi Development toward repayment of our \$31,000 loan drawn to pay for the move and structural retying of The Doctors' House.

We have started to receive donations of furniture for the house, necessitating the formation of an Acquisitions Committee under Sue Lazara This committee will determine furnishing needs and criteria for accepting donations.

Another new committee, formed by Lee Sales, will set up a dynamic docent training program enhanced by a lively format.

Throughout the year we have reached out into the community with our slide programs conducted by Greta Reed and her committee, our newsletters edited by Suzanne McKay, our monthly meetings arranged by Dr. Robert Newcomb, our TV spot on Channel U designed by Jerry Jaskulski, our participation in Webb's Day, and our articles contributed to <u>Glendale</u> Today magazine.

Our concerted efforts to convince the Glendale Redevelopment Agency to require the preservation of the Egyptian Village Cafe were ultimately of no avail, as the Agency accepted the plans of the American Trading Real Estate Company to raze the Jensen Building housing the Cafe. Our presence in the community this past year has been positive and very visible. The foundation has been laid for an active role in the years to come. -- Carole Dougherty

AD HOC COMMITTEE ON REDEVELOPMENT

In October 1982 the Glendale Redevelopment Agency appointed a sevenmember Ad Hoc Committee to make recommendations on the redevelopment process. Historical Society president Carole Dougherty is on this committee, which has been meeting weekly with the various people involved in the redevelopment of downtown Glendale.

The committee received reports from Redevelopment Agency staff and consultants and various city service department heads; testimony from previously affected property owners and businessmen; and statements from Glendale residents including Sue Lazara, vice-president of the Historical Society. The committee toured the three historic sites in the redevelopment area, the Alex Theatre, the Egyptian Village Cafe, and the Masonic Temple building.

The committee is now preparing its recommendations for submission to the Redevelopment Agency in February. The issues it will address in its report are the negative reaction to redevelopment in the community, owners' and tenants' lack of knowledge of their rights and relocation benefits, alleged abuses during the acquisition of property for redevelopment, the delay between the issuance of exclusive negotiating rights and relocation of businesses, dissemination of information of the ELS Design Group's suggested redevelopment plan for downtown and redevelopment progress, and the impact of redevelopment on traffic in the downtown area. A final report on the committee's recommendations will appear in the next newsletter.

The Glendale Historical Society is among several groups of local historical and preservation organizations participating in a project assessing the needs and priorities of historic preservation in the State of California. This project, the California State Historic Preservation Task Force, was established by a State Senate Concurrent Resolution during its last session. The task force is to operate from November 1982 to November 1983 with the aim of drafting a proposal for consideration by the State Legislature after January 1, 1984. The report will address state issues in historic preservation, the need for effective co-ordination among preservation groups, and the cultivation of a broad spectrum of possible funding sources essential for preservation work. The task force includes sixteen members, drawn from state and local preservation groups, the building and construction industries, state and local governmental bodies, and the building trades unions.

Because of its broad mandate and its comprehensive membership the task force has been divided into two sections, one for the north and another for the south of California. Several meetings have been held in our part of the state, and Roger Holt, the task force chairman, has been organizing the forces necessary to carry out the survey of needs and to complete the report.

The Glendale Historical Society is privileged to be among those groups involved in the Southern California Section of the task force. This project will give an important statement to the State of California regarding policies for the advancement of historic preservation.

STATUS OF THE MASONIC TEMPLE BUILDING

One of Glendale's first high-rise buildings on Brand Boulevard, the Masonic Temple Building, is currently in the possession of a bank which foreclosed the property last July. The General Bank of Commerce took possession of this imposing eight-story building at 232 South Brand when the owner, Joseph Gruber, developed financial problems. Mr. Gruber had been in the process of converting the 60,000 square feet structure into a dining and entertainment complex with an opulent 18th century theme.

Mike and Barbara McIver of Ambience Enterprises had been directing the renovation, which took advantage of the rooms' original purpose as social gathering areas for the expanding Masonic organizations when the building was constructed in 1929. The rooms include a sixth-floor banquet hall seating 600; the spacious seventh-floor Blue Room; and other reception rooms and lounges. In keeping with the Louis XV motif envisioned for the complex, numerous murals and other hand painted details have been added to the walls and ceilings, and stained glass has been utilized in the foyer.

The ground floor auditorium is being leased by the U. S. Cinema, the southernmost of the six popular movie theatres on Brand Boulevard. A large room on the third floor was used for the auction of Mary Pickford's estate in 1981.

The reinforced concrete construction makes the Masonic Temple Building exceptionally sturdy, and fire safety code requirements are already satisfied in several respects.

This building stands as an example of the optimism and energy of Glendale citizens in the 1920s. It is included in the "Historic Preservation--Second Order Criteria" section of the Glendale City Planning Division report of 1977, but it is located in an area subject to redevelopment. The Glendale Historical Society strongly supports its preservation in the face of redevelopment and owership changes, and will continue to make recommendations in this regard to the Redevelopment Agency.


