

PRESIDENT'S ANNUAL REPORT: 1987-1988

At the occasion of the Society's June Business Meeting it is customary for your President to provide a "State of the Society Address". After this past busy year of activities, I am much helped by access to the working summaries of your Board Members and special activities chairs. To them in recognition of this past year's ready and cheerful support I say, on behalf of all the Society members, "Thank You".

Our general monthly public meetings continued as before in the hospitable Carrillon Room of Glendale Federal Savings. These rooms are currently undergoing renovation, and we look forward to returning to newly decorated surroundings this coming Fall. Our on-going business meetings succeeded in the membership of the Society well informed regarding the finances and working committee projects which are the backbone of our addition, we were favored by a succession of guest lectures on various topics of interest. The trials and tribulations of the Los Angeles Central Library and the start-up of historical studies of fire fighting in Glendale were shared with us last Fall. The spring lecture season of 1988 brought to us insights about the challenges of restoring old theaters, the marvelous history of the Mount Lowe Railway, Part Two of the history schools in Glendale, and a celebration of 70 years of the American Red Cross in Glendale and La Crescenta. Special celebrations by the Society took place in September 1987 at "Villa Montgomery" when our Awards Presentations took place, and in December 1987 when the proprietors of "The work" at the Masonic Building opened facilities so that we could celebrate the Festive Season in style.

Our financial status over the past bookkeeping year indicates that we are still on the positive side of the ledger even if the assessments for our insurance tend to dampen our fiscal enthusiasm. Sales and dues are of the utmost importance on the income side, and I personally feel that those making disbursements on behalf of TGHS do so with great responsibility and outstanding prudence. So, if we are not a wealthy society, we continue to pay our way and to be self-financing. Particular thanks are due to Treasurer Dick Montgomery, without whose eagle-eyed examination of our finances we would be much the poorer.

In terms of our public outreach efforts, the Doctors' House docents, the Speakers" Bureau, and our presence at preservation activities such as Carroll Avenue open house assure that our banner is displayed.

When we turn to the working groups of the Society there is a great deal to report for this past year. The 30 Docents at the Doctors' House hosted 3,424 visitors during our normal Sunday hours and special tours. This most enjoyable and highly visible expression of TGHS in Glendale and the favorable publicity which it garners is a thrill for us personally and a great contribution to our community. During the course of this past year

our TGHS Preservation Action Task Force has labored 'mightily and brought forth the Alex Theatre Report which is proving to be so influential in gaining support in our community for the rehabilitation of this handsome structure. The Task Force has also worked with those attempting adaptive re-use of the former Masonic Temple building and of the Goode House. The Task Force folk maintain a lookout in support of the interests of several other structures on the City's <u>Historic Preservation Element</u> and, in addition, serve as a most effective liaison with planning and preservation groups in Glendale, within Southern California, and in Sacramento.

Publications have had a banner year for the Society with the creation of How to Research Buildings in Glendale, The Early Glendale Fun Book for children, and the centennial poster featuring The Doctors' House. These items are in addition to our on-going sales of other relevant publications and books and stationery. We await with great interest the completion of our map of Glendale's historic sites, which will serve to really put historic Glendale before the touring and resident public. The four issues of our well-wrought Newsletter which were published within the past year continued the tradition of providing information about our organization's activities and outreach efforts as well as giving advance notice of preservation events around our community. The introduction of flyers which announce our monthly meetings has proven to be a welcome assist to those attempting to keep their respective activities on schedule.

Our Society Historian has continued to work with scissors and glue to assemble a lasting record of historic preservation and the efforts of TGHS in our town. Membership affairs, an obvious essential to the livelihood of a group such as ours, reminds us annually of dues and works the year around to recapture to our fold strayed members currently in arrears.

In closing I may say that our Society continues to develop a place for itself within the community as a voice in support of the preservation of the past and in providing expert information and advice on such matters. Each of us contributes to this image and each of us can gain from its public projection. It is in the community of association, however, that we truly experience our Society and its works.

ALEX THEATRE UPDATE

Since the April publication of their 65-page report <u>Preservation of the Alex Theatre</u>, members of the TGHS Preservation Action Task Force have been meeting with community leaders to discuss the preservation of the Alex and its possible conversion to a live performing arts center. These discussions, which have included the cultural committee of the Glendale Partners and the Glendale Regional Arts Council, are providing opportunities to study other successful examples of historic theatre preservation and to explore the means and approaches for converting the Alex. Our meetings, like the public forum held at the Alex in March, indicate that we share the goals of groups such as the Partners and the Arts Council, which are committed to actively fostering a high quality of life in Glendale.

The Task Force report, which gives detailed statistics and examples of historic theatre restoration, has attracted the attention of other preservationists, one from as far away as Minnesota. We are hopeful that the expertise and dedication of our Task Force will continue to be effective in helping to maintain the life of this unique and treasured theatre.

TGHS APPEALS CITY DECISION ON GOODE HOUSE PLANS

Out of concern for the possible detrimental effects of a developer's plans for the century-old E. D. Goode House and its surroundings, our organization has invoked a provision of a State law, the California Environmental Quality Act (CEQA) in order to ensure that the historic integrity of the site is maintained. On June 2 the TGHS Preservation Action Task Force filed an appeal to the Glendale Environmental and Planning Board, pointing out that CEQA requires that an environmental impact report be prepared for any project which could have an adverse impact on a site of historic or aesthetic significance. The Board had stated that no environmental impact report was required for the project.

Following the appeal, Board hearings have been held at which Task Force representatives, community members, and attorneys Bill Delvac and Jack Rubens have explained the significance of the Goode House and its potential for listing on the National Register of Historic Sites. The Environmental and Planning Board has now stipulated that changes to the interior and exterior of the house must conform to the Secretary of the Interior's standards for historic preservation. However, we are urging them to also require that the proposed additional buildings not disqualify the property from National Register eligibility — that is, that they do not hide, distract from, clash with, crowd, or otherwise abuse the house or contribute to the loss of its historic setting.

The Task Force will continue to work with the developers and the City toward finding a creative and practical way to preserve this Queen Anne-Eastlake gem.

CALIFORNIA STATE HISTORIC PRESERVATION CONFERENCE

TGHS representatives David Smith, Dr. Robert Newcomb, and Suzanne McKay joined over 300 other registrants at the 13th Annual California State Historic Preservation Conference held May 19-22 in Palo Alto and on the Stanford University campus. The conference, hosted this year by the California Preservation Foundation and Palo Alto-Stanford Heritage, consisted of presentations, tours, and social events providing the participants with information, inspiration, and the opportunity to form or renew contacts with professional and volunteer preservationists from throughout California.

Robert attended workshops on preservation and politics, rehabilitation in downtown Palo Alto, history and preservation education, neighborhood protection, and preservation and cultural diversity. David chose sessions about preservation and the law, good design decisions, and historic theatre preservation. Suzanne selected presentations dealing with the services of the State Office of Historic Preservation, historic resource surveys, seismic retrofitting of historic buildings, and computers for non-profit organizations.

We particularly enjoyed learning of our statewide counterparts' adventures and experiences in historic preservation, and discovering the many human, organizational, and published resources available to us. We hope more TGHS members will take advantage of such conferences in the future, in particular at the Biltmore Hotel in Los Angeles in spring 1989. In the meantime, we are already starting to apply some of the things we learned to help our organization in its various projects.

REDEVELOPMENT AGENCY APPROVES REHAB PLANS FOR MASONIC BUILDING

The future appears bright for Glendale's landmark 1929 Masonic Temple building at 234 South Brand, following the June 7 approval by the Glendale Redevelopment Agency of Phase I (conceptual plan) of the firm Frank De Pietro and Sons. Evolving from the De Pietros' many months of careful design work and discussions with the TGHS Preservation Action Task Force and the State Office of Historic Preservation, the plans are based on the developers' desire to create a successful commercial building which will be eligible for National Register listing.

The owners propose maintaining the ground floor as a theatre and modifying the upper floors to suit commercial tenants. The west (Brand Boulevard) facade will retain its essential elements, but such features as an elevator tower attached to the southwest corner and additional windows in the north and south walls will be added to satisfy modern occupancy needs. Our Task Force will continue to provide assistance to Robert and Dennis De Pietro as they proceed in their project, a "first" for our downtown.

SHARE YOUR ARTISTIC SKILLS



WANTED: COMPUTER RESOURCES


