"THE DOCTOR IS IN"



"The Doctor Is In" is the theme of The Doctors' House fall exhibit, which opens Sunday, September 29 with a 2 pm - 4 pm reception. Antique doctors' equipment will be displayed and pre-1900 medical advice and folklore will be posted throughout the house.

Most of the medical instruments are from the collection generously donated by Mr. William Dillard of San Diego. The implements he gave us are from the collection of his father, who practiced medicine in the early part of this century. These include a blood pressure gauge, obstetric supplies, an aspirator, dental pliers, tonsil snares, and old diplomas and books. Most of the instruments were identified by retired cardiologist Dr. Paul Shearer, husband of Doctors' House docent Ethel Shearer. However, some were a mystery to him, and we eagerly solicit visitors' suggestions as to the identity of these tools.

In addition to the recently acquired instruments, the display will include our Civil War amputation kit and turn-of-the-century hypodermic needles and syringes. A "doctor and patient" will be consulting together in the doctor's office during the opening reception, and surprise refreshments will be served.

Visit the exhibit throughout October and November and learn valuable advice such as --

For whooping cough, breathe into your lungs the breath of a fish

PLANS FOR ALEX THEATRE TAKE SHAPE

The Committee for Arts at the Alex (CAA) has continued to make significant progress since our last newsletter:

- * Richard McCann and Leon Sugarman were selected as project architects and began the programming phase in late July. This phase which will be completed in early October includes research of the theatre's architectural history; preparation of an operational proforma budget and event calendar; preliminary designs and renderings; and a feasibility plan on the cost and impact of installing the Fox Lanterman organ;
- * Structural engineers John Kariotis & Associates have assessed the theater and found it to be structurally sound overall, with only a few areas requiring reinforcement;
- * An environmental consultant has identified all toxic substances in the theater and estimated the costs of removal;
- * The Ratkovich Company has been selected as Project Manager to coordinate theater rehabilitation on behalf of the City;
- * Members of CAA are creating a nonprofit corporation which will consist of members appointed by City Council. The nonprofit's role will be to oversee the rehabilitation process, conduct fundraising, and select and manage the theater operator;
- * A project timeline is being developed which sets the rehabilitation completion at twelve to eighteen months from the time the theatre is acquired by the City;
- * CAA held a public forum September 21 at the Alex Theatre offering the public an opportunity to hear about CAA's plans and to comment on the project.

CAA has kept Glendale's Historic Preservation Commission abreast of its progress through presentations at Commission meetings. Recognizing the Historic Preservation Commission's role as guardian of our local landmarks, CAA will continue to work with them as progress continues. CAA's current goal is to conclude its work and issue a final report to the Glendale Redevelopment Agency by the end of October. If the Agency decides to proceed with the project, CAA will recommend that the project be managed by the nonprofit corporation.

Through representatives Andrea Humberger and David Smith, TGHS and the Alex Theatre Revitalization Project continue to play an active role in CAA's progress. TGHS remains committed to a preserved and rehabilitated Alex Theatre as both a state-of-the-art performing arts center and a historic landmark recognized in the National Register of Historic Places.

"DESIGNATION 1990S" TEAM GEARS UP FOR ACTION

"Designation 1990s" was launched last year to identify and document important cultural resources that are potentially eligible to the City's landmark list (the Historic Preservation Element) and to assist property owners in researching and writing nominations to be considered for landmark designation. Volunteer teams, which have developed project materials and sponsored a landmarks designation workshop, are now ready to begin their work.

"Designation 1990s" is a program consistent with the City of Glendale's preservation ordinance which can provide research and volunteer assistance to extend City staff capabilities. Seeking support and cooperation for this program from the City, TGHS submitted a request for \$3000 to City Council for consideration during the allocation of "Community Promotion" funds during the 1991-1992 budgeting process. The funds were requested to help fund the services of an historic preservation professional for project guidance and continued training of our volunteers; TGHS planned to match the City's grant.

We regret that City Council did not grant the funding request. Nevertheless, we plan to move forward by hiring a consultant on a more limited basis and to begin writing nominations of important cultural resources which are as yet unrecognized. TGHS plans to work in cooperation with the City's Planning Division and the Historic Preservation Commission in this endeavor.

"ART DECO: WHAT IS IT? WHERE DID IT COME FROM? WHAT IS IT DOING HERE?"

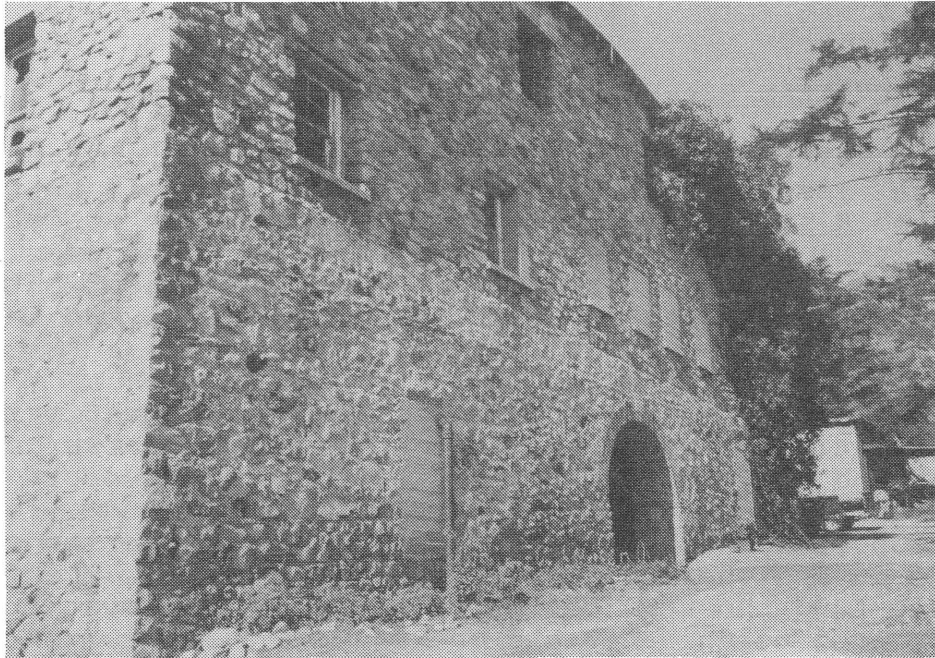

CURRENT PRESERVATION ISSUES STATUS REPORTS

Public Service Building: A public hearing was held in July to determine the scope of the Environmental Impact Report (EIR) on the proposed demolition of the Public Service Building. The hearing was conducted by consultants Paula Kelly, Ray Pendro, Martin Weil, and Michael Krakower. Over thirty interested individuals attended the hearing, including representatives from TGHS, Taxpayers to Save Glendale \$Millions, Northwest Glendale Homeowners, Adams Hill Homeowners, the Los Angeles Chapter of the American Institute of Architects, City Council, the City's Planning Division, and the Historic Preservation Commission. The 45-day public review period on the draft EIR begins October 11; all public comments must be made by November 24. TGHS and many other interested organizations and individuals plan to comment on the draft EIR. Following completion of the final EIR in December, a final decision on the future of the Public Service Building will be made by City Council.

Inter-Valley Ranch and Winery: Now called Deukmejian Wilderness Park, the historic Inter-Valley Ranch and Winery are designated local landmarks (i.e., listed in the City Historic Preservation Element) acquired in 1989 by the City of Glendale. A master plan is currently being developed for the 700 acres to become a wilderness park. The plan, which was presented at a public hearing in July, includes the rehabilitation and reuse of the historic stone barn (previously considered a winery) as a classroom; the development of trails; and renovation of the equestrian stables area. According to City officials, most of the park will remain in its natural state offering picnicking, hiking, historic and architectural history, nature study, wildlife observation and equestrian activities. TGHS supports the aim of this project, which is to preserve the property's natural, historic, and architectural resources. We commend the City for its work thus far on the project.

TGHS RECEIVES ART DECO SOCIETY AWARD

A special Art Deco Preservation Award was given by the Art Deco Society of California to The Glendale Historical Society for its efforts to preserve the Alex Theatre. Michael Crowe, Founding Director of the Art Deco Society, traveled from San Francisco to present the beautiful Art Deco certificate to us at our June 15 Awards Presentation.

The Art Deco Society is dedicated to the preservation of California's Art Deco heritage. The organization sponsors activities in preservation, entertainment, and education and serves as a resource for information on Art Deco architecture.

The Art Deco Society has long supported our efforts to preserve the Alex Theatre, whose landmark tower and marquee are in the Art Deco style. PLANNING FOR PRESERVATION

The City of Glendale Planning Division has undertaken several projects aimed at promoting historic preservation in our community. Department staff and consultants under the leadership of new Preservation Planner Gerald Wasser are involved in several projects which will provide recognition for the people, events, and buildings which have contributed to our identity as a city. The projects are meant to foster a sense of pride and caring, and to help ensure the preservation of some of the most valuable aspects of our heritage.

Two current projects are the Certified Local Government Grant Program and the Mills Act Property Tax Incentive Program. The Certified Local Government Grant was applied for by our Historic Preservation Commission, and matched by City funds. The California State Office of Historic Preservation awarded this grant to Glendale contingent on the preparation of National Register forms and nominations. Under the grant program, the City hired architectural historian Carson Anderson and historic researcher David Cameron to survey Glendale's downtown area (between Belmont, Wilson, Brand and Harvard) for buildings, especially multi-family residential buildings, having such special historic qualities that they appear eligible for nomination to the National Register of Historic Places. Their observations and research revealed five potential sites for which they wrote nominations: the Ellis T. Byram House (ca. 1883), the Edgar Douglas Goode House (1893), the Maryland Hotel (1925), the Glendale Hotel (1925), and the Glendale Y.M.C.A. (1926). These buildings were all discovered to have significance due to their particular association with early Glendale leaders, their stature as representatives of particular eras in Glendale's history, their fine embodiment of period architectural styles, and (in the case of the Glendale Hotel, designed by Arthur Lindley and Charles Selkirk) their architect. The consultants have submitted their findings to the City Historic Preservation Commission, and will be forwarding them to the State Office of Historic Preservation.

A second current project is the Mills Act Property Tax Incentive Program. The Mills Act is a State tax provision which allows for property tax reductions as an incentive for private owners of historic properties to restore, rehabilitate and maintain their properties rather than alter or neglect them. Glendale Planning Division staff are formulating the details of the program as it would apply to Glendale. Under the program, the owner of a building listed in our Historic Preservation Element (a list which is expandable) could sign a contract to preserve and, if necessary, rehabilitate his or her property in accordance with the standards of the California State Office of Historic Preservation. The Mills Act program benefits the property owner, the neighborhood, and the community.

In addition to these two current projects, Mr. Wasser and Planning Division staff will be working on several other projects to heighten citizens' awareness and appreciation of Glendale's history. They will continue to promote National Register nominations and to establish public education endeavors such as an oral history program, two short history videotapes, brochures and maps. They will co-ordinate with both State and local governmental bodies in various programs.

This increased activity in preservation planning is due in large part to the enthusiasm and hard work of Gerald Wasser, and we commend him for his involvement. We also commend our City for according such value to historic awareness and historic preservation. We are pleased to see their recognition of historic resources as assets to both residential and commercial areas, and their promotion of knowledge of and pride in our city's unique character.

At our October 2 monthly General Membership meeting (7:30 pm, Carillon Room, Glendale Federal Bank), Carson Anderson and David Cameron will present a program about their research methods and findings during their National Register research in downtown Glendale. Preservation Planner Gerald Wasser will be the featured speaker at our November 6 meeting. He will discuss the various projects on which he and his staff are working, and how the public can become involved.

Spotlight on Service: Sue Lazara



Sue Lazara was born and raised in Linden, a small town in northeastern Texas. She attended Southern Methodist University where she earned a BS in Mathematics with a minor in statistics. After moving to Glendale in 1971, Sue worked as a consumer research analyst for the Los Angeles Times. After completing a year of postgraduate work in Mathematics at USC, she worked at a private consumer research company for seven years. While raising three sons, now 14, 12, and 9, Sue managed a local business for five years. She currently works as Project Director for D/R, Inc., an international consulting and research firm.

Sue joined TGHS in 1981 soon after The Doctors' House was moved to Brand Park. Serving as Project Historian, Sue researched the history of the house and conducted physical research of its interior. With Marie Luft, Sue supervised restoration work and project contractors. She also provided measurements and drawings, collected missing hardware, researched and taught restoration techniques to volunteers, and wrote the docent training manual. As Chair of the original Acquisitions Committee, she organized fundraisers, set up a donation program, researched and drafted a collection plan, worked with donors, and organized the acquisition of most of the main furnishings in the house. Sue also served as Doctors' House Liaison to the City, Lead Docent, a member of the Docent Council, and a Director on the TGHS board.

As Chair of the Preservation Task Force beginning in 1987, Sue led the writing of the TGHS report on the preservation of the Alex and acted as an advocate on behalf of TGHS on many preservation issues. In 1988 she organized a lecture series cosponsored by TGHS and Brand Art Associates on neighborhood conservation and home restoration. Sue organized a tour of historic sites in Glendale for participants of the California Preservation Foundation conference held in Los Angeles in 1989. In 1990 Sue launched "Designation 1990s" for which she has developed project materials and organized a landmarks designation workshop. Last spring Sue helped organize our City Council candidates forum, compiling an extensive reference package on preservation issues for the participants.

Sue also serves on the Board of the Glendale Youth Orchestra and the Lanterman Historical Museum Foundation, and is active in the PTA and her church. She enjoys many hobbies, including reading, sewing, and playing piano. She often makes the costumes for church and school plays and accompanies student musicians on the piano.

Sue consistently demonstrates her belief in the importance of giving to her community. She is a person of strong commitment and perseverance who works to promote important quality of life issues. Sue is an exceptional person with many talents which she gives generously. TGHS salutes and thanks Sue for her outstanding contributions to our organization and to the City of Glendale.
