Two recent exhibits at the Doctors' House were very successful. "Death and Grieving Customs in Victorian Times," during October and November, 1996, was an informative and interesting display which made a visit to the Doctors' House very rewarding. The exhibit would not have been possible without the team of docents who contributed their time and talents to the display. Special thanks go to **Bonnie Fitzgerald, Merry Franzen, Isabelle Meyer, Bob Newcomb, Nancie Pike, Judy Sackson and Bill Shepherd.** Also contributing to the display were our neighbors, the **Little Landers Historical Society.** An extra thank you goes to **Cranberry House Antiques** which loaned us some antique clothing and **Tali Ilan** who loaned us some jewelry. Both loans were welcome additions to the exhibit.

Upon the closure of the "Death and Grieving Customs in Victorian Times" exhibit, the House underwent its annual transformation for Christmas. The Docent Guild presented its 4th Annual Christmas Candlelight Tours of the Doctors' House on December 14 and December 21. A bake sale/holiday boutique was held both nights. Regular Sunday tours occurred on December 1, 8 and 29, 1996. Many thanks to all of those who contributed bake goods to the bake sale. And of course, very special thanks to the docents who donate so generously of their time to staff the House.

Some elves cleaned the house on February 1 under **Marie Luft's** direction. The Doctors' House thus shined for the lucky romantics who won the fourth annual "Valentine's Day Dinner." The dinner was provided by **La Fontana Restaurant.**

**Nancie Pike and Isabelle Meyer** have begun to update the inventory of every item in the House. This will aid us in ensuring everything is properly stored and preserved. They hope to have this project completed by the end of the year.

The annual docent tea was held at **Isabelle Meyer's** house on January 25, 1997 with ten docents in attendance. The results of a recently distributed docent questionnaire were discussed. Input from the docents continues to be helpful for new events and to make our program more effective and enjoyable for everyone.

The most recent docent training class was held on January 26, 1997. It was very successful with nine new docents joining our group. Five docents speak Armenian and two speak Spanish, a great help with so many visitors from other origins. A welcoming social was held at the **Goode House** on February 9 so that the new docents could meet the experienced docents. **PROPOSAL:  
A DOCTORS' HOUSE GAZEBO**

TGHS has an exciting new project underway: a proposal to construct in Brand Park, adjacent to the Doctors' House Museum, an elevated 20-foot octagonal gazebo, customized to the Victorian period with details adapted from the House. Specifically, porch details from the House's moongate, or curved, arches and railings. These details will be modified in the other four openings to give full public access, three by means of steps and the fourth a ramp for disabled persons, the gazebo thus lending itself to a wide range of uses.

Its proposed site is in the vicinity of the existing flagpole. With the Doctors' House as a focal point and backdrop as seen from the gazebo, the addition of such a covered structure will provide an ideal setting for weddings, receptions, and film and photography use, with fees charged contributing to the maintenance of both the gazebo and museum. The gazebo will also be an ideal venue for concerts in the park, theatre performances and community functions. And, most importantly for TGHS, it will provide museum patrons with seating and much needed shelter from inclement weather. In the absence of such a structure, many tours must be cancelled during extended periods of rain or excessive heat.

Furthermore, since the Doctors' House is furnished with period antiques, the interior can be used only for small scale social events. With the gazebo, the potential for larger events exists, sponsored by either TGHS, the City of Glendale, or other community groups.

Not only would the facility generate increased income but also increased numbers of people visiting the museum.

The Gazebo Committee, consisting of Marie and Glenn Luft, Isabelle Meyer, Nancie Pike, and Carol Eckert, worked closely with Nello Iacono, Director of Parks, Recreation and Community Services, in developing the gazebo concept. The proposed project was unanimously approved by the Parks, Recreation and Community Services Commission and recommended for City Council approval by the Historic Preservation Commission. On September 24, 1996, it received approval by the Glendale City Council.

The construction of the gazebo will be supervised by Marie and Glenn Luft. Marie served as project manager of the Doctors' House restoration; Glenn is a civil engineer and served as the construction superintendent of the restoration. With their assistance, Isabelle Meyer, the Doctors' House Docent Coordinator and TGHS Director, and Nancie Pike, a lead docent, researched several manufacturers of gazebos, and numerous contractors were interviewed to determine the most cost effective combination of value and historical compatibility. Based on this research, TGHS plans to purchase the basic framework of the 20-foot octagonal "Pagoda" gazebo from Amish Country Gazebos of Ontario, California. The company can customize the details of the gazebo to reflect the intricate Victorian craftsmanship of the Doctors' House Museum.

## GAZEBO (Cont.)

As to historic accuracy, no attempt will be made to construct a gazebo exactly "to the period." First of all, the Doctors' House never had a gazebo on its original property, although such structures were common in that period, one, for instance, near the front of the Goode House. Secondly, *because* the Doctors' House now resides in a public park and *not* in its original location, more latitude is allowed in such secondary structures. Every attempt will be made to create a compatible, but not duplicate, structure, with enough distance (approximately 50 feet) between it and the Doctors' House to allow appropriate visual separation. In addition, when seen in its entirety, the gazebo itself - should announce its current time period. The detail ornamentations to give it compatibility, grace and beauty.

Cost estimates to complete this project are between \$40,000 and \$45,000. TGHS proposes to fund it primarily through grants obtained from foundations. Carol Eckert, TGHS Vice President, has taken on this aspect of the project and is currently submitting applications. Carol is the Director of Marketing and Fund Development of the Camp Fire Council of the Foothills, and it was because of her enthusiasm and belief in the viability of the project in terms of grant success that it was initially undertaken. David L. Smith, TGHS President and CPA and Hovic Khaloian, CPA, along with Dick Montgomery, Treasurer, have given generously of their time and expertise in preparing the necessary financial records required for the grant applications.

In addition to foundation grants, there will be an opportunity for TGHS members to support the project. A fundraising campaign, spearheaded by Bill Shepherd, TGHS Director, will get underway later this year. Recognition will be given to *everyone* who participates by being listed in *TGHS Quarterly*. Donations of over \$100 will be recognized on a placque such as was done for the Doctors' House. The placque would be installed alongside those at Brand Park.

### Annual Preservation Conference in Nearby Pasadena

The 22nd Annual California Preservation Foundation Conference, "Preservation Comes Home," will be held in Pasadena on May 29, 30, 31 & June 1, 1997. The conference features educational sessions focusing on neighborhood conservation, architectural history, economic development and technical issues in preservation. Those interested in historic preservation, planning, development and neighborhoods will find the conference rewarding.

The 1997 conference site is the DoubleTree Hotel in Pasadena's historic Civic Center, adjacent to Old Pasadena. Jointly sponsored by the California Preservation Foundation, the City of Pasadena and Pasadena Heritage, the conference will be cosponsored by the California Office of Historic Preservation and the National Trust for Historic Preservation. Numerous Southern California preservation groups, including The Glendale Historical Society, will be involved as participating organizations. ## PRESERVATION UPDATE

**Byram House (227 North Everett Street):** This property has been purchased by a private party for use as a 12-step house. The current plan is to do very limited rehabilitation work to the historic residence. The City may contribute rehabilitation funds. If so, TGHS hopes that the City will make sure that the rehabilitation is sensitive to the history and architecture of the residence.

**San Fernando Road Corridor Redevelopment Area:** The historic resources survey for the new San Fernando Road Corridor redevelopment area was released in August. TGHS submitted extensive comments on the survey in September. Comments from TGHS as well as other members of the public and the Historic Preservation Commission have been incorporated. The Commission has forwarded the survey to the Redevelopment Agency for approval. Following the Commission's final discussion on the matter on November 19, TGHS submitted additional comments. In our next issue, we will report on the findings of the survey, response to our final comments, and any Agency action.

TGHS has also received a copy of the Draft Design and Implementation Plan for the new redevelopment area. We are currently in the process of reviewing it and will comment.

**Exemption of Churches from Glendale's Historic Preservation Ordinance:** The City has proceeded with the preparation of an Environmental Impact Report (EIR) on this important matter. TGHS attended the scoping session for the EIR in August. The Draft EIR was released in December. TGHS submitted a comment letter and spoke at a public hearing on the matter on January 21, 1997. TGHS maintains its longstanding position, adamantly opposing de-listing of the three churches from the landmark list. On March 3, 1997, the Historic Preservation Commission postponed action. It is still tentatively scheduled to go before City Council on March 18, 1997.

**Downtown Strategic Plan:** In September, the Preservation Advocacy Committee met with representatives of the GRA and the Environmental Impact Report (EIR) consultant to discuss the EIR on the Plan as well as the Plan itself. Based on the meeting and the Committee's input, TGHS submitted extensive comments on both the EIR and the Plan. Since that time, the Final EIR, including responses to public comments, and redrafted versions of the Plan have been released. On November 19, City Council approved the fourth draft of the Plan and certified the EIR. The Final EIR was responsive to TGHS comments and added language to the document which would have required additional efforts to be made to preserve and incorporate historic buildings into the Plan. However, we are disappointed to report that the City Council adopted findings which undermine the majority of the preservation language which was added.

**Glendale Railroad Depot (Gardena Avenue at Cerritos Avenue):** We commend the City for its completion and submittal of a National Register nomination for the landmark depot. The nomination will soon be considered by the State Historical Resources Commission.

ANNALEE GARDNER OLMEDO**

A few weeks ago the Acquisitions Committee received a phone call from a young gentleman who, following the wishes of his recently deceased mother, offered several items to the Doctors' House Museum.

His mother, Annalee Gardner Olmedo, a long-time Glendale resident, had visited the museum on several occasions and was particularly enchanted with our candlelight tours. She, therefore, decided to pass on some of her many collectibles to the museum so they could be enjoyed by our many visitors.

We do not often get a chance to view an extensive collection of antiques and to be told to select whatever we would like to have. For the Acquisitions Committee this is a dream come true! With the help of our expert appraiser, Bonnie Dunlap, we narrowed our selection down to five items. They include a turn-of-the-century microscope and wooden chest of medicines perfectly suited to the doctors' office.

I did not get a chance to personally meet Mrs. Olmedo, but thanks to her son who provided some information about her and her family's life in our town, I feel that I have come to know her a little bit.

Annalee was born in 1936 and spent all 58 years of her life here. She attended Glendale High School and later Stevens College and USC. She was the dedicated manager of local charity thrift shops, including the American Cancer Society thrift shop in Sherman Oaks and the Assistance League of Southern California thrift shop in Hollywood.

She must have had a great love of historical artifacts to have accumulated such an extensive collection and variety of things. We appreciate her thoughtfulness in sharing them with the Glendale historical Society and the public.

Annalee's grandmother, Grace Gardner, named Alpha Road near Glorietta Park and her father, Donald L. Gardner, was a well known dermatologist. In return for sharing his expertise with trainees, he was the first doctor commissioned by the Atomic Energy Commission to use radioactive isotopes in his practice. His wife was an active in the Oakmont Country Club.

We would like to thank Annalee's only child, Mark, for fulfilling his mother's last wishes and hope that he will feel a little bit at home when he visits his family's belongings at the Doctors' House Museum.

## NEW HISTORIC PRESERVATION COMMISSIONERS

Two new commissioners have been appointed by the Glendale City Council to the Historic Preservation Commission. New commissioners Shirley Owen and Jennifer Davis began service on the Commission in November.

Shelly Owen is a California Archeologist who has specialized in the field of Cultural Resource Management for the past seven years. She has served on over 100 cultural resource management projects, the majority of which she managed as field director or project manager. She specializes in preservation planning and archeological and historical studies as they apply to state and federal environmental requirements. Owen has authored or co-authored over 100 technical reports, research designs, cultural resource management plans, and environmental impact documents. She has lived in Glendale since 1972 and graduated from Cresenta Valley High School. She holds a Bachelor of Arts Degree in Anthropology from UCLA.

Jennifer Davis has worked as an Associate Urban Planner for the City of West Hollywood since 1990. Among her diverse responsibilities in that position, Davis was the first staff person to implement West Hollywood's Cultural Heritage Preservation Ordinance. In that capacity Davis helped form the City's founding Cultural Heritage Board and educated the Board, staff, and public on the Ordinance. Her initial tasks also included introduction of the West Hollywood's first landmark designations and certificate of appropriateness applications. Davis grew

up in Cincinnati, Ohio. A Glendale resident of two years, she holds a Bachelor of Arts in Urban Planning from the University of Cincinnati.

The two new commissioners have replaced Georgia Abelmann and Marlene Roth who have both recently completed their second terms. Owen and Davis join Chairman Richard Dell, Michael Dougherty, and Dolly Carl on the Historic Preservation Commission. We look forward to working with the new commissioners on important projects which impact Glendale's historic resources.
